SIDS4/SDG DATA ALLIANCE: IN 2024, THE SDG DATA ALLIANCE CONTINUED TO MAKE SIGNIFICANT STRIDES IN ADVANCING SUSTAINABLE DEVELOPMENT THROUGH DATA-DRIVEN SOLUTIONS, PARTICULARLY IN SMALL ISLAND DEVELOPING STATES (SIDS) AND COLLABORATION WITH SIDS4, THE FOURTH INTERNATIONAL CONFERENCE ON SMALL ISLAND DEVELOPING STATES, A HIGH-LEVEL UNITED NATIONS CONFERENCE FOCUSED ON ADVANCING SUSTAINABLE DEVELOPMENT IN SMALL ISLAND DEVELOPING STATES (SIDS). PVBLIC FOUNDATION PLAYED A PROMINENT AND STRATEGIC ROLE AT SIDS4 - BOTH AS A PARTNER ORGANIZATION AND AS A KEY DRIVER OF DATA AND TECHNOLOGY INITIATIVES SUPPORTING SIDS RESILIENCE AND SUSTAINABLE DEVELOPMENT. PVBLIC CO-LED SEVERAL SESSIONS AND ENGAGEMENTS AROUND THE SDG DATA ALLIANCE, A GLOBAL MULTI-STAKEHOLDER INITIATIVE THAT SUPPORTS GOVERNMENTS - INCLUDING MANY SIDS - IN BUILDING NATIONAL DATA ECOSYSTEMS FOR SUSTAINABLE DEVELOPMENT. THROUGHOUT THE YEAR, THE SDG ALLIANCE HOSTED WORKSHOPS IN 5 COUNTRIES, ENGAGING MORE THAN 260 PARTICIPANTS FROM OVER 30 COUNTRIES, INCLUDING 27 SIDS NATIONS. THE ALLIANCE WAS ALSO REPRESENTED AT 9 MAJOR GLOBAL EVENTS (ROTTERDAM, ANTIGUA, SAN DIEGO, NEW YORK, ETHIOPIA, AZERBAIJAN, SAUDI ARABIA). THE ALLIANCE'S ENGAGEMENT IN KEY EVENTS SUCH AS THE SIDS CONFERENCE IN ANTIGUA AND BARBUDA WAS A HIGHLIGHT, WHERE IT SUPPORTED THE LAUNCH OF THE SDG DATA HUB FOR CARIBBEAN SIDS. CAPACITY-BUILDING WORKSHOPS IN MEXICO, TONGA, AND FIJI PROVIDED TAILORED SOLUTIONS TO ENHANCE GEOSPATIAL DATA FRAMEWORKS, ADDRESSING THE UNIQUE CHALLENGES OF CLIMATE RESILIENCE, LIMITED RESOURCES, AND GEOGRAPHICAL ISOLATION FACED BY PACIFIC AND CARIBBEAN NATIONS. THESE INITIATIVES HAVE EMPOWERED SIDS TO INTEGRATE DATA SOLUTIONS INTO THEIR SUSTAINABLE DEVELOPMENT STRATEGIES, FURTHERING PROGRESS ON CRITICAL GOALS.

IT BRINGS TOGETHER LEADERS FROM GOVERNMENT, CIVIL SOCIETY, MEDIA, PHILANTHROPY, PRIVATE SECTOR AND CREATIVE SECTORS IN INFORMAL, INFLUENTIAL SETTINGS. IN 2024, THE SDG LOUNGE WAS CONVENED BY THE UNITED NATIONS OFFICE FOR PARTNERSHIPS DURING THE 79TH SESSION OF THE UN GENERAL ASSEMBLY HIGH-LEVEL WEEK AT THE UN HEADQUARTER AS A DYNAMIC FORUM. IT BROUGHT TOGETHER HEADS OF STATE, BUSINESS LEADERS, CREATIVES AND CIVIL SOCIETY FOR UNSCRIPTED DIALOGUES AND INTERACTIVE SESSIONS ON THE SUSTAINABLE DEVELOPMENT GOALS. THE LOUNGE EMPHASIZED INNOVATION, CREATIVITY AND COLLABORATION TO ACCELERATE SDG PROGRESS, ESPECIALLY THROUGH SECTORS LIKE FASHION AND LIFESTYLE, MEDIA, TECHNOLOGY AND YOUTH LEADERSHIP.
